Ryan motioned to close the budget. Scott seconded. Motion carried.


System O&M

- Beaver dam at drop. Ice off canal. There has been some washout again.


Scott motioned to adjourn at 7:22 p.m.



Board Compensation



Each trustee of the Tridell Lapoint Water Improvement District will receive an annual payment of \$845, based on 12 yearly meetings, and with the Board Chairman's agreement that said trustee is in good standing for the year. Any special meetings will entitle board members to an additional \$70.42 per meeting. The Board Chairman will receive an annual payment of \$1056.25 per year with special meetings being paid at \$88.02 per meeting. The trustees of the board as a whole shall agree on the Board Chairman's compensation prior to payment.

When attending training or meetings, board trustees shall receive compensation at a rate of \$100.00 per day, in addition to the cost of their training, mileage reimbursement, meals and lodging.
